We will follow the midway ISD calendar for holidays. Make-up lessons are available in the fall semester only.

Tap/Ballet students are required to wear black leotards and pink tights. Pink or white ballet shoes and black tap shoes (tie or slip on). Dance skirts, leggings, & spandex shorts are optional. Black Jazz shoes (tie or slip on) are required for jazz students. Leotard/tights (color of your choice), jazz pants, leggings, or spandex shorts (if tights are underneath) are permitted. No gum, candy, or food in the studio area. **Please bring your own water, there is no water fountain.**
